

Special Meeting
November 12, 2014
5:30 p.m.

With due call and notice thereof, the November 12, 2014 Special Council Meeting of the City of Eden Valley was called to order by Mayor Korman at 5:30 p.m. in the Civic Center meeting room. Present were Mayor Korman, Councilors Gabrelcik and Kern and Clerk Haag. Absent: Councilors Bradshaw and Thielen. Also present Police Chief Junker and others. Mayor Korman presided.

The purpose of the special meeting was to canvass general election results and certify delinquent refuse bills for collection on property taxes in 2015.

An Abstract of Votes Cast at the November 4, 2014 General Election was provided by Meeker County Auditor Barb Loch and Clerk Haag included a summary of ballots cast and write in votes which were reviewed by the City Council acting as Canvass Board. Result were as follows: For the office of Mayor, two-year term – Brent Bengtson and for the office of Council, four-year term – Dan Thielen and Janice Sheets. After review, a motion was made by Gabrelcik to approve the Abstract of Votes Cast and summary of ballots cast and write-in votes as presented. Motion was seconded by Kern and carried unanimously.
